## SHOWMANSHIP

Participants **MUST** have a team name and coordinating theme. The theme should be carried throughout the competition with music and outfits, along with capturing and enhancing the fun and spirit of the Southern Hushpuppy Championships. Your team is responsible for transporting props, decorations, etc. into and out of the arena. You are not able to drive into the arena for any reason. Southern Hushpuppy Championships Coordinators and/or Texas State Forest Festival staff will not assist in transportation or setup of showmanship equipment and/or decorations. **All team equipment and decorations must be brought in through the front gate by team members.** No exceptions.

## JUDGING

There is a minimum of three (3) official judges for the competition. All hushpuppies are tasted and judged on a point system based on **taste, uniqueness, and appearance**. Your organization will be identified to the judges by your **TEAM NUMBER ONLY**.

# OFFICIAL RULES & REGULATIONS



**Hushpuppy** | A small, round or slightly oblong cake of cornmeal fried in deep fat.

**Garnish** | To enhance in appearance by adding decorative touches.

**Pre-mixing** | To combine, add, join, blend, create, or form ingredients into one mass or mixture.

1. Contestants compete in only one of the assigned 30-minute preliminary heats.
2. First, second, and third place is awarded in each preliminary heat. **The top eight (8) overall scores in all heats combined advance to the Championship heat to compete.**
3. Each contestant cooks a **minimum of twelve (12) hushpuppies. Six (6) samples** must be sent to the judges' stand upon signal.
4. A time limit of 30 minutes per heat is allowed. A signal begins and ends each heat. You may not heat your oil or begin mixing ingredients until the signal is given.
5. Contestants are **RESPONSIBLE FOR THEIR OWN** ingredients. Cornmeal, oil and paper towels are provided by Hytop and Brookshire Brothers.
6. Only **four (4) team members are allowed to cook**. Anyone who is not competing will not be allowed in the cooking area. If you have more than four team members, they must stay in the audience **or you will be disqualified.**
7. Each contestant has a special nametag displaying his/her team number that the judges use to identify your hushpuppy. Your organization or company name will not be given to the judges.
8. Contestants are allowed to chop, cook, grate, etc., any ingredient needed for preparation of hushpuppies prior to their heat. No premixing (see definitions to know) of any type is allowed.
9. Contestants are responsible for placing their hushpuppy samples on a tray provided by an official Hushpuppy Hostess. The hostess will take the hushpuppy samples to the judges... **NOT THE CONTESTANT!**
10. Contestants may occupy designated cooking areas 5 minutes prior to beginning of heat and must remove their ingredients, utensils, etc., immediately following their heat.
11. Teams are allowed to receive a copy of their score sheets, upon the request of the contact person, after the Texas State Forest Festival.
12. In the event of a tie, the team with the most points in the uniqueness category breaks the tie. If still a tie two teams will be declared co-winners of the category in which they are tied.
